I. POLICY

The Emergency Medical Services Communications System has been developed to allow for effective EMS Dispatch and prehospital medical control in the Central California EMS Region. The use of the EMS Communications System in Fresno, Kings, Madera and Tulare Counties will be in accordance with the EMS Policies and Procedures.

II. DESIGNATED AMBULANCE DISPATCH CENTERS

A. Ambulance Dispatch Centers - The EMS Agency has approved the following communication centers as the designated ambulance dispatch centers for each county:
