I. Welcome

Vice Chair Manny Piceno filled in to Chair the meeting and called it to order at 3:32 p.m.

II. Approval of Minutes from the July and August Behavioral Health Board (BHB) meetings The draft Minutes for July were approved as written. Upon completion of a few suggested edits, the drafted August meeting minutes were also approved.

Director Susan Holt began her presentation with the monthly acknowledgements for September. While September has many nationally acknowledged days related to behavioral health, it is commonly known for being National Suicide Prevention Month and National Recovery Month.

<u>Legislative Updates - Select Items of Note</u>

September 30th is a key date remaining in the Summer/ fall timeline for the Legislative Process, as it is the last day for the Governor to sign or veto a bill. During this year's legislative session, DBH tracked 220 bills that had a connection to behavioral health and that would / could have an impact on behavioral health. Session will reconvene on December 2nd, and the Department will take a deeper dive into the legislative bills and present items to the BHB that may have an effect on behavioral health. *Please see attached for a highlight of a bills currently pending action*.

Suicide Data

There were nine deaths by suicide that were reported for July 2024 as of August 5th, 2024. It was also mentioned that during the time of COVID, Fresno County's number of deaths by suicide remained relatively the same which was unique in comparison to other counties.

B. Overview of TURN Behavioral Health, Full-Service Partnership (FSP) IMPACT Program

Since June of 2014 DBH has had a 10-year service partnership with TURN Behavioral Health, formerly known as Mental Health Systems. Executive Leadership and Program Management attended the meeting and were acknowledged by Director Susan Holt for the job well done over the years of working together.

The IMPACT programs target population is Adults, Older Adults with dual diagnosis of severe mental health and substance use disorders. With low staff to client ratio the program has a multidisciplinary team available 24-hour / 7days a week to assist individuals with the following services.

- Therapeutic interventions, medication management / monitoring, psychiatry
- case management, supportive housing services, vocational rehabilitation, comprehensive outpatient, and community services

While each individual receives services from the multidisciplinary team, they each have an assigned Personal Service Coordinator who acts as a single point of responsibility for coordinating services and supports. Each program and all multidisciplinary team members practice the embedded five core MHSA concepts of:

- Recovery/resiliency
- Cultural competence
- Community collaboration
- Person served/family driven
- Integrated service experiences

C. Update on the transition of the new Patient Rights Advocate

On March 15, 2024, the agreement DBH had with the previous Patients' Rights Advocate (PRA) was ended and a short-term purchase agreement was started with the Smith Waters Group Inc., a well-known PRA service provider for several other counties. Within this agreement the services include and are not limited to, mandated services, certification review hearings, mental health facility monitoring, training with education/mental health law.

PRA data pulled for the last quarter:

- June 2024 117 Hearings held, and 191 person served contacts.
- July 2024 151 Hearings held, and 188 Person served contacts.
- August 2024 151 Hearings held, and 191 person served contacts.

During this transition of PRA providers, the department will continue to focus on orienting the PRA with partner organizations and their relationship development to aim for collaborative problem solving and future service monitoring with data collection. Meanwhile the Request for Proposal is in development to create an agreement and take to the BOS.

Legislative Updates - Select Items of Note

- Legislative process remaining key dates in timeline summer/fall:
 - September 30 Last day for the governor to sign or veto bills
 - December 2 Session reconvenes
- During this year's legislative session, we tracked 220 bills with a connection to or impact behavioral health
- Highlights of a few bills pending action:
 - SB1238 (Eggman) LPS Designated Facilities
 - AB 2106 (McCarty) Coerced SUD Treatment as a condition of probation
 - AB 1842 (Reyes) and AB 2115 (Haney) Medication Assisted Treatment
 - SB 26 (Umberg) CARE Scholarship Program
 - SB 1400 (Stern) Removes statutory authority for a court to dismiss a case without first considering other programs like CARE Court
 - Expands data required to be reported by County under CARE report
 - Note this bill was amended at the eleventh hour

Program Outcome Highlights FY22/23

- Target goal: 75% reduction in hospitalizations, incarcerations, homelessness, crisis visits
 - Arrest- 80% experienced a reduction in arrests.
 - Incarceration- 80% experienced a reduction in incarceration.
 - Homelessness- 34% experienced a reduction in homelessness.
 - Hospitalization & crisis visits- 80% reduction in the number experiencing psychiatric hospitalization or crisis visits.
 - Psychiatric hospital days- 80% of consumers experienced a reduction in psychiatric hospitalization days.
- Target goal: provide services to 140 unique individuals
 - Number of unique individuals served: 138, with 80.4% remaining engaged in services 6 months or more
