Questions

Are bids only through Bid Express?

Bids will be accepted via hardcopy or electronic bids.

Are bid details due within 24 hours only if you win the bid?

The due dates and times for post-bid details and documents are listed in the Specifications and Instructions to Bidders. Post-bid details and documents are required for any bid to remain responsive.

Where are we getting the water to drill with? Where will drill cuttings be stored/disposed?

Refer to the Specifications.

Do the existing wells work?

Yes.

Is placement of blow water decided?

Refer to the Specifications.

Will the current well be off during operation/construction?

The current well is the only water source for the community. Contractor shall coordinate with County operator the possibility of temporarily turning off the well.

Is it a gravel pad?

County will make the drillers log of the original well available under Supplemental Information.

Is there something wrong with the current well?

No. This project provides a back-up water source.

Do you know where it's perforated and does it meet water quality standards?

Refer to the Plans. Casing perforations matches existing well. The existing well produce water meeting Title 22.

What is the required flow rate?

The expected well production rate is 200-240gpm based on existing well. The contractor will pump test the well for the Engineer to determine the well capacity as part of the project.

Does the tank by existing well have water?

Yes. Existing well pumps to the existing tank.

Where is the school's well?

The school is supplied by the County well.

Will the fence come down for access?

Yes, refer to the plans, sheet C3 for fencework, the permanent well easement and the temporary construction easement for staging.

Will the school's baseball backstop stay?

Refer to plans, sheet C2. The backstop will be removed by others.

Where is the new fence going to go?

Refer to the Plans.

We just pick it up by the fence?

Refer to the Plans.

Is the area next to the tank going to be available for storage and staging?

Refer to the Plans.

Will residents be notified of work?

Refer to the Specifications.

Does current well feed tank by the school?

Yes. The well supplies water to the school. The school fills up the tank occasionally as the tank is for fire supression only.

Does current well have pipes going to school?

The school is being supplied by a connection outside the work area.

Do you have an approximate start time?

Refer to the Specifications.

Any way to extend term past 100 days?

This will be addressed in an Addendum.

Looking to break ground in March?

The anticipated award date is December 17th. Notice to Proceed to submittals is approximately 20 working days after award.

Does PG&E or SoCal service the area?

PG&E supplies power to the system.
