Conditions of Exemption

According to Public Resources Code (PRC) §42954(a)(7), a person who hauls waste or used tires is exempt from registration under this chapter if the following condition is met: the person, who is not a waste tire generating business, is transporting waste or used tires to an amnesty day event or to a location that meets the conditions specified in subdivision (b) of Section 42951, and has received written authorization, which includes specific conditions and dates, from the local enforcement agency.

1. This exemption must be signed and approved by the Fresno County Local Enforcement Agency (LEA) prior to hauling 10 or more waste tires.
2. This exemption must accompany the load of waste tires and be presented upon request to any uniformed peace officer, authorized agent of the LEA, or the California Department of Resources Recycling and Recovery (CalRecycle).
3. This exemption only grants the transportation of waste tires for the day of hauling to the aforementioned disposal location and does not allow for the transportation of waste tires for hire.
4. The waste tires shall be transported in a safe manner that (a) does not endanger public health and safety, and (b) does not allow waste tires to fall from the transporting vehicle.
5. One-day hauling applicant shall submit disposal receipt to the LEA as proof of proper tire disposal within seven days.
